1. COMPANY PROFILE

OTPCL, a joint venture company of Orissa Hydro Power Corporation Ltd (OHPC) and Orissa Mining Corporation Ltd (OMC) (two of the leading PSUs of Govt. of Orissa), has been set up for setting up a coal based thermal power plant of 3x800MW capacity using super critical technology in Kamakhyanagar in the State of Orissa. The company has been incorporated with an Authorized Capital of Rs. 1000 Crore. The land detailing activities has already been completed. The process for acquisition of private land and transfer of Govt. land has already been initiated. The Company has already signed the long term Power Purchase Agreement (PPA) with GRIDCO Ltd (The Bulk Power Supplier Licensee operating in the State of Orissa.) to sell the power to be generated. The Coal requirement of the Company will be catered from the share of allocations of OHPC & OMC from their respective shares from the Baitarani Coal & Mandakini-B coal Blocks allotted under Govt. dispensation route by the Ministry of Coal in Gol. The Company has also applied for tampered coal linkage under state quota till the commercial production starts from both the coal blocks. The water allocation for the project has also been received. The Company has already engaged some of the Infrastructure Consultants for the project and also on the verge of engaging Project Consultant & Environmental Consultant etc. The company has planned to set up the plant in the 12th Plan in a time bound manner.

2. JOB DESCRIPTION AND RESPONSIBILITIES

The Managing Director as the Chief Executive Officer will be responsible for overall functioning of the organization. He will be responsible for successful Implementation of the mega power project within budget and time period. As the leader of the project, he will be responsible for successful implementation of the project.

3. ELIGIBILITY
